

Sistemi Sociali e Gestione del Potere (la Società-Specchio)

In our research *I Sistemi Sociali e la Gestione del Potere - La società degli Specchi (The Social Systems and the Power Management - The mirrors Society)* we deal with the problem of the Power Management as a specific function of Social Systems.

We try to operationalize the Social and System concepts trying to define them in a new rational manner, seeing them in their continuous creation and recreation of their meaning boundaries. So a specific operational paradigm becomes functional to analyze them in their relational indicators and correlations making and rearticulating, their way of establishing aggregations, integrations and new integrative or alternative productions that are functional to the specific work's assumptions.

We hypothesize a similar-neural System model to clarify the logic and the rules needed to analyze the processes through which social facts and relations are generated by specific combinations of the factors involved. In particular we investigate what we define the *mirror phase* that qualifies a social System specific self-construction of an impossible Identity.

What we suggest here is one of the possible models to arrive to define a reliable construction of the contemporary world in some of its dimensions and in the variety of this particular social phenomenon (the psycho-sociological reconstruction of the Power Management) within the social systems.

We interconnect a series of informative and operative data through an attention directed to let emerge multi-acting *twins-systems*, which can explain and predict Power Management experiences and functions, in the emergence of social specialized groups more or less connected with the direct Management of Power.

We have so the possibility to obtain the intensity degree of the social Power Management in function of the positions of Social Elements in curves that can show reciprocal self-regulations obtaining that nobody is excluded from a political management game but only very few can act a really influential active role.

For the emerging of a new explicative situation, we introduce a new political differentiating category: the *selective political-economic Rationalization*. We describe, in mathematical terms, a set of variables, parameters and laws which may allow the possibility of hypothesizing the System's behaviour and its consequences.

We analyze either the characteristics of the *cause-black box-effect* and the situations of the *before-black box-then*.

All this is possible by introducing the Uncertainty Principle of Heisenberg also in the psychological and sociological research in reference to the single social Element with all its possible relationships.

As for the enormous masses, taken as a whole, and for the most important decisions and choices involving extensive groups of social elements (given that all the different social Elements' freedoms are effectively summarized in a normativeness and so in an all-inclusive right), the global behaviours are represented in the their statistical variety.

For both cases (either the single social Elements and the groups of social Elements), we analyse the factors that determine, and/or manage, the homeostasis, i.e. the reaction, the feed-back, the adaptability, the self-learning, the self-reproduction and the evolution.

And also the measurement of the System's disorder (the entropy) as well as the level of absorption from the order (the negentropy).

The result of this research is a synthetic analytical description consisting of a series of curves, that can clarify the complex relationship between the structure that involves the "civil" way of life and the political-institutional structure that encloses the same "civil" way of life.
